CLC Task Force Group

Purpose

The role of the CLC Task Force Group is to lead and co-ordinate the industry activities identified in the 1st June 2020 Roadmap to Recovery – the Industry Recover Plan for the Construction Sector and the deliverables established by the respective Working Group and Workstreams. The Task Force Group is responsible for day to day matters of the CLC and supports all activities and issues relating to short and medium-term needs as the convening and representation group for the CLC and the wider industry.

The Membership will be drawn from Government departments, Industry and Trade Associations who are able to represent the industry overall. Selection is by invitation from the Industry Co-Chair. However, Council members are able to offer suitable candidates to represent them if they are unable to attend meetings or events from their groups or companies, providing there is no conflict of interest.

Where the Industry Co-Chair is unable to attend, he/she will elect a member of the group to act as Chair.

To be quorate at least ten members must be present at the meeting, two from Government Department and eight from industry and Trade Associations.

Frequency of Meetings

Meetings twice weekly until further notice.

Attendance at Meetings

Members they are expected to attend a minimum of 50% of meetings in any year.

The Steering Co-ordination members are also members of the Task Force and are expected to attend the Task Force meetings when possible.

The Task Force members will be required to attend the CLC meetings with the Strategic Advisors Group.

Other parties may be invited to attend the meetings to offer advice and guidance to the Group.

Roles & Responsibilities

- Assist and contribute to the strategy for the CLC and future direction for the industry
- Provide support and resources to the CLC and assist with communications with Government and Ministers
- Undertake a convening role for the construction industry and endeavour to address concerns and issues on strategic and operational matters
- Lead, manage and co-ordinate the Working Group and Worksteam Activities, report progress to the other Council members
- Review, monitor and co-ordinate intersections between the Working Groups and Workstreams to avoid duplication or conflict
- Review future trends, risks and opportunities and advise actions to be considered and taken
- Action, review and monitor the strategy to ensure it is aligned to the delivery of the 2025 and other targets
- Assist with development of key measures, monitor and report progress regularly
- Engage with the wider industry, represent the CLC at industry conferences and forums
- Monitor succession planning and talent management within the various working groups ensuring there is diversity throughout the groups
- Support communications and lead on activities agreed by the Council members

Terms of appointment

The effectiveness of the Task Force Group will be reviewed after 12 months, including the terms of reference and membership/composition.
